

**TOWN OF NORMAN WELLS
BY-LAW NO. 19-01**

BEING A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF NORMAN WELLS IN THE NORTHWEST TERRITORIES TO PROVIDE REGULATIONS FOR THE DISPOSAL OF LAND IN THE TOWN OF NORMAN WELLS PUSUANT TO THE CITIES, TOWNS & VILLAGES ACT, S.N.W.T. S.N.W.T. 2003, C-22.


WHEREAS the Council for the Town of Norman Wells deems it to be in the public interest to dispose of the lands described under, and

WHEREAS the said parcel of land is not required for municipal purposes and has been developed for the purpose of disposal to private interests;

NOW THEREFORE the Council of the Town of Norman Wells enacts as follows:

1. That the whole of Lot Six Hundred Forty-Three (643) Plan Four Thousand Five Hundred Ninety Eight (4598), Road Two (R2) Plan Three Thousand Four Hundred Seventy Six (3476) and Road One Hundred Two (R102) Plan Four Thousand Five Hundred Ninety Eight (4598) in the Town of Norman Wells in the Northwest Territories be sold and conveyed to **Imperial Oil Resources NWT Ltd.** of Calgary, Alberta (purchaser) in consideration of the sum of One (\$1.00) Dollar upon the following terms and conditions (**Lot 643, Plan 4598, R2, Plan 3476, R102, Plan 4598**):
2. That the Mayor and the Senior Administrative Officer are hereby authorized on behalf of the Town of Norman Wells to execute all such forms or applications, deeds, indentures and other documents as may be necessary to acquire the said lot from the said owner for **fee simple title**.
3. That the purchaser is responsible for paying the Transfer of Title fee to the Land Titles Office.
4. Schedule "A" is attached and forms part of this by-law.
5. Land Acquisition By-Law 12-13 and 18-09 are hereby repealed and Land Acquisition By-Law 15-04 is hereby amended.
6. This By-Law shall come into force and effect upon completion of third reading and otherwise meets the requirements Cities, Towns and Villages Act, S.N.W.T. 2003 C-22.


