- 1. Administrative Report- Ambulatory Care attached
- The Fire Chief is frustrated with the lack of progress relating to proper ambulatory care. He has had multiple meetings with key partners with no progress made. The consensus of all parties is that there needs to be a change in the standard of care that is available in Norman Wells for emergency transport services.
- Health and Social Services, the RCMP and the Fire Department are all in agreement that an ambulance or transport vehicle is needed. Patients have been transferred to the medical centre in the back of a pickup truck. This is not only a liability for the patient's safety but also for the safety of the first responders.
- Designated transport nurses have access to a Ford Flex- this is not for emergency transport. Designated transport nurses are liable in the same degree as fire fighters.
- Fire fighters may assist the nurse getting the patient to the Ford Flex.
- There is funding available for municipalities for up to \$50,000 per year for emergency transport services depending on the community.
- The municipality gets called on for winter road emergencies. In other communities, no department would attend outside of the municipality.
- The Department of Transportation plays an active roll in ambulatory care- the Town could enter into an agreement to attend certain accidents on the winter road with certain equipment.
- Councillor Bernard expressed frustration regarding medical transport and training. He noted the Town is not any closer to getting something done by having these conversations. He would like to be able to safely transport a patient in emergency situations. He noted that it could be any one of us or our loved ones in the back of a pickup truck receiving life saving care.
- Council agreed to send an emergency resolution to NWTAC.
- Councillor Wever asked if the Town has inquired about using industry medical services to get us by. The Fire Chief responded that yes, recently there have been preliminary discussions. The conversations involved contracting a separate company for emergency transport. There are logistical problems when entering into agreement for a shared ambulance as there could be emergencies at the same time for each party.
- The SAO noted there is a risk involved- and maybe Council would like to take it. The SAO will get ahold of insurers for more information regarding insurance and liability for ambulatory care.
- The SAO also noted that it is important that the community know that Council and the Fire Department are having conversation that will lead to having best practices and minimum standards for emergency transport services.
