d) All-Terrain Vehicles By-Law #21-03

Discussion

- a. Admin Report

- c. By Law #05-91- Repeal of ATV By Laws
- There is currently no active ATV By-Law. All previous by-laws have all been repealed.
- The By-Law Officer is recommending that the use of helmets be mandatory within town limits on any all-terrain vehicle including snow mobiles.
- During the spring and summer months, Jaime will educate the public about the importance of helmet
- The Norman Wells RCMP fully support this by-law.
- The RCMP are willing to donate money to purchase helmets for those who cannot afford them.
- Jaime will reach out to both stores in town to ensure they are able to bring in helmets for community members to purchase.
- All three readings should be done by early fall.

- The Development Officer provided an updated property list as payments had been made after the meeting agenda was posted.
- All attempts at contacting property owners have been exhausted (registered mail, email, hand delivered letters, notice sent that there would be a council discussion).
- In the last two weeks, four properties have been removed from the list.
- Council would like to remove properties from the list who owe less than \$5,000.
- The minimum bid on the property has to be the assessed value.
- Councillor Audet requested admin develop a process for this to share with Council.

10. Council Forum

- Councillor Bernard:
 - Would like to send letter of congratulations to the newly elected Mayor and Council in Tulita.
 - Suggested signage indicating where sidewalks and walkways are as there have been quite a few people walking down the highway.
 - Suggested possibly marking the side of the roads to help prevent vehicles from going off the road in certain places around town.
- Councillor Audet:
 - Asked when the new phone system would be arriving. Staff responded that it has arrived and is in use and they will contact NWTEL to fix the connection issues.
- Councillor Wever:
 - Would like admin to reach out to transportation to request signage be put at the entrance of Town advertising the Covid-19 restrictions (specifically for long haul truckers).
 - Suggested the Town Free Pantry become an actual charity so the Town can issue tax receipts.
 - o Would like to advertise the PATH Program to residents who qualify. Admin will reach out to Housing for more information.
- Councillor Peachey:
 - Suggested having admin set up onboarding for potential new Councilors as it is an election vear.
 - o Combination of the SAO's experience, current Council's experience, and MACA.
 - She also suggested possible workshops for the community so that residents may better understand municipal government.
- Councillor Smith:
 - Requested additional maintenance and snow clearing on some roads that are in bad condition, specifically Mt. Avens and Franklin. The Town may have to revisit the snow clearing standards.
 - Jackfish Lake road has not yet been plowed. It was confirmed that the road would be cleared this winter at the Regular Council Meeting December 1, 2020.
 - Mayor Pope noted that safety is priority, if there are any roads that require extra work please advise the SAO.
 - The Dental Team informed the community through Facebook that the medical centre could not accommodate them to come back for another visit. Councillor Smith will send copy of the comments to Mayor Pope who will reach out to the medical centre for answers.
