  - Asked about the lighting upgrade at the curling club. Alex responded that most of the funding for the project was used up for the arena lighting. The department receives yearly grants that will help fund future projects as well as incoming federal grants that the department is looking into.

     Councillor Peachey is currently preparing a report to share with Council.

  - Informed Council that the Marten Avenue Housing Contracts have opened. One home has a bid that is close to \$900,000. He advised Council as it is tax payer money being used to develop these homes.
  - At the NWTAC meeting, Senator Anderson mentioned that she is currently working in the Northwest Territories. She expressed interest in open invitation to communities to discuss federal concerns.

  - Suggested writing a letter of invitation to Senator Anderson to meet with Council.
  - He thanked Councilors Peachey, Wever, and Bernard for attending the NWTAC AGM.
  - Mayor Pope attended a Waterboard meeting with Gary and Hugo. The Town's water license is in good compliance.
  - There is a ceremony on the Arctic Circle that will unveil a logo in the form of a drum. The Town has been invited to participate if anyone is interested.
  - He has agreed to an interview with Sirius XM radio regarding businesses and covid-19. Frank will share the channel information with Council.
