k) Trans-Canada Trail Expansion

Resolution

Concern raised about the piles left at the side of the trail from this project. Rob Closs responded via the Zoom chat function that piles are frozen and will be cleaned up once they have thawed.

The Great Trail (formerly known as the Trans-Canada Trail) has confirmed that the trail extension can be added to the Norman Wells portion and be eligible for funding. Questions raised about maintenance. Trail would be eligible for funding under gas tax.

Several councilors, the mayor and the SAO commented on the positive public perception of the trail network and this extension. Councillor Boyle stated he could not support if the trail continues to not allow certain things (vehicles) on it.

Material will go through the weigh scale. The Town will not be responsible for maintenance until the trail is completed and linked to our current trail system.
