Misty Rayner, the Coordinator of Emergency Measures, walked Council through the scope of the plan and the different areas of authority as detailed in the Norman Wells Community Emergency Plan. The Town is currently operating under a Level 1 – Local Control with no GNWT Support Emergency Response Level (page 10 of plan).

A declaration of a State of Local Emergency expires seven days after it is made unless it is sooner cancelled by the Minister or terminated or renewed by the local authority (page 16).

A committee with representatives from 25 local organizations has been proposed to ensure that there is full community input. The committee provides input to the Emergency Management Agency as the roles and responsibilities outlined in the plan (page 8).

The first meeting of the committee is tentatively scheduled for Monday, March 23<sup>rd</sup>, 2020. The first meeting will be a working session; future meetings will be open to the public. The public will be updated after this meeting.
