## FOR DISABLED PERSONS EXEMPTION:

I declare that I am a disabled person, as defined as follows in the <u>Senior Citizens and Disabled Persons Property Tax Relief Act</u>; and that I am the sole owner or part owner of the single family dwelling unit or mobile unit in which I live.

A disabled person means an individual who at any time on or before December 31 of the application year:

- (a) is in receipt of a pension or allowance
  - (i) for a total disability or a partial disability of at least 25% under the <u>Workers</u> <u>Compensation Act</u>,
  - (ii) for a severe and prolonged disability under the Canada Pension Plan, or
  - (iii) for a disability of at least 50% under the War Veterans Allowance Act; or
- (b) produces a medical certificate satisfactory to the Minister responsible for Municipal and Community Affairs indicating that the person suffers from a severe or prolonged disability and setting out the nature and extent of the disability.

And I make this solemn Declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath, and by virtue of the <u>Canada Evidence Act</u>.
