6. New Business

- a) Role of the Economic Development Committee as part of a municipal government
- The Committee expressed their frustrations with the overall function of the Economic Development Committee (EDC).
- Members are frustrated that the Recreation Committee was able to hire a consultant when the EDC's initial proposal to hire a consultant did not pass through Council.
- Members have put in a lot of volunteer hours researching to advance the Committee with no results from their hard work.
- Administration recognized this frustration and suggested that the Committee propose again to Council the need and benefits for hiring a consultant.
- The EDC is eager, willing, and excited to make and impact in the Town of Norman Wells.

- Members would also like clear direction from Council on what they believe the goals are for this Committee.
- Administration will assist the EDC in creating a report to bring forward to Council that will represent the goals of Council's Strategic Plan.
- The EDC members expressed their desire to be tools to Councillors and other Committees regarding items that fall under the capacity of the Committee.
- The Committee acknowledges they need a By-Law, Committee Procedures, training, clear direction, and support to move forward as a successful Committee of Council.
- The Committee agreed that Council Reps and Members must advocate for a proposal with other Members of Council as well as the Mayor.
- The EDC feels strongly about keeping \$ in the Sahtu Region and the Town of Norman Wells to reinvest back into the local economy.
- The Committee would like to meet with Industry more regularly. Members believe a partnership with Imperial Oil would benefit the Committee and the Town of Norman Wells greatly.
- Members agreed that to move forward as a successful Committee better communication with Industry, Council, the Mayor, as well as Town Administration is required.
- Members would like to have a completed proposal to present to Council by November 3, 2020.
- The Committee expressed that they would like to be apart of the Regular Council Meeting call outs done when staff creates the agenda for Council Meetings
