# a) RCMP Monthly Policing Report

- 39 calls for service.
- Continued proactive checks on released offenders.
- Continued winter road patrols. Norman Wells' jurisdiction is 25km outside of town; officers offer help to other detachments when needed.

- The department is currently understaffed with temporary relief coming in to help.
- Officers continue to monitor drivers leaving the Legion and other establishments to help prevent impaired driving.
- Councillor Audet asked if officers are happy with the 25km radius of patrol on the winter road. Sean responded
  that it needs to change as the department has more capability to respond to incidents; it is not fair to the other

  - Nurses from the health center have expressed their gratitude for the department's ground transportation services. They noted that it has greatly helped with fatigue.

    due to increased calls in the region. Susan will be putting together a proposal for Council for review as the vet

  - Mayor Pope has directed administration to provide a response and information for a fruitful discussion of Council for a Committee of the Whole meeting April 3rd.
  - Mayor Pope presented a resolution to close the water and sewer services request for tender in order to negotiate a 2 year extension with Northridge Contracting as per clause c 18 in their contract. We are not able to negotiate with a tender out for public review; the tender must be withdrawn in order to negotiate.
  - Councillor Peachey noted that this gives Council the opportunity to review the Purchasing By Law and RFT process.
  - Councillor Smith asked if the contract could be extended for one year. Mayor Pope responded that as per the terms of the contract, it must be extended for two years.
