a) RCMP Monthly Policing Report

- Continued attendance at community events.
- Met with social services regional manager to keep lines of communication open.
- Continued proactive checks on conditionally released offenders.
- Proactive checks on vehicles leaving the legion to prevent impaired drivers.
- 43 calls for service were local clientele, none from out of town.
- 4 calls for service regarding mental health.
- Worked with the Fire Department on medical calls and transport. Response time has been great. Constable Thomson thanked the department for their continued support.
- The department is looking further into increased drug activity in town. Officers are in constant contact with surrounding communities as well as the federal unit out of Yellowknife. Constable Thomson noted it takes a lot of time to eradicate drug issues.

7. Departmental Reports

- a) Town Manager
 - Staff have added a communications component to their reports as staff are in constant contact with individuals and organizations in town.
- b) Finance
 - Tentative meeting to discuss draft audited financial statements is April 25, 2023.
- c) Fire Department/By-Law
 - The Fire Chief has been asked to be a Town representative on the Canol Youth Leadership Hike this summer. He asked Council for their support to attend the hike.
 - The department will begin recruiting of new members soon.
 - The nurses at the health centre have expressed their gratitude for the department's assistance with ground transportation services.
- d) Governance & Community Engagement
 - Continued work on communications.
 - Industry connections include working with Mackenzie Mountain School, Norman Wells Land Corporation, North Wright Airways, Legion, and GNWT on the Advancement of Equity and Inclusion Committee's Women of Excellence Awards.
- e) Lands- no report
- f) Public Works
 - Street stripping is nearly complete. The Public Works Manager and local contractor are discussing the process for street stripping the south subdivision which should be starting tomorrow.
 - The transfer station runs on a trust system. The department is looking to mitigate ongoing issues including dumping outside of the transfer bins.
 - Lids should be installed soon.
 - The Public Works manager noted that most people are good and are respectful of the processes that are currently in place.
 - Spring projects include Landfill Phase 2, Chipseal Project, Road Repairs, the final phase of clean up on Cotourierre's lot, and brining the south subdivision back up to grade.
 - Municipal as and when RFT is now closed.
 - Municipal Snow Clearing RFT is now closed.
 - Municipal Dust Control RFT extended to May 17th.
 - Municipal Civil Works RFT extended to May 17th.
 - The Public Works Manager has been in contact with Lloyd Woloshyn of Nuna on behalf of HRN and is now the single point of contact between TNW and HRN until David Hodgson returns to town. Jason Tarcon from IOL is now the single point of contact between TNW and IOL regarding any quarry aggregate needs.

Councillor McCoy asked if anything can be done about the snow overhanging on buildings in town square as it is a safety concern. The SAO responded that is the responsibility of building owners.

g) Recreation

- The department has begun the transition from winter to spring programming.
- Staff finished their pools course at the end of March and are now well prepped for pool season.
- The department has worked with the Norman Wells Land Corporation to share grant information that may be beneficial for them and will help create opportunities for community programming.
- Spring Clean up will be on May 28.
- The head lifeguard will be arriving in May.
- h) Utilities
- The department is in regular contact with the Environmental Health Officer, MACA's Sahtu Office regarding certification renewal and MACA's water sanitation department in Yellowknife.
